MEMORANDUM:

The undersigned presents compliment to the Additional Collector, Bombay Suburban District and with reference to his letter No.LND.CR.142, dated the 16th June 1967, on the above subject is directed to convey the sanction of Government to his proposal to allow the Danda Daryavardi Sahakari Kharedi Vikri Sangh to use the land measuring 186 square yards out of Survey No.308 of Danda for the purpose of installation of diesel pump through the Indian Oil Corporation for a period of 5 years, on payment of rent of Re 1/-p.a. and ~~submit~~ subject to the following conditions:-

- i) that the pump will be installed by the Indian Oil Corporation at its own cost and will be run by the Danda Daryavardi, Sahakari Kharedi Vikri Sangh Limited. The Indian Oil Corporation will be entitled to rental of re 1/- only per month for the equipment supplied by it.
- ii) that the pump shall be used for the use of the members of Sangh only and not for the members of the Public and also not for Commercial purposes.
- iii) that the profit if any derived by sale of diesel oil to the members of the Sangh should be utilised for the uplift of the Sangh only and not for any other purpose.
- iv) that the supplies of High Speed Diesel Oil will be made by the Indian Oil Corporation against the cash payment by the Sangh.

v) that this permission shall be liable to be cancelled and land resumed to Government without payment of any compensation for breach of any of the conditions.

2. The Collector should get an agreement executed in respect of the above permission by the Singh in proper ~~proper~~ form. He should also see that the Singh had sold Oil to its members only and after considering the income the Singh derived by ~~sale~~ of diesel oil and proper verification that the pump is being used by it for legitimate purpose.

3. This memorandum issues with the concurrence of the Finance Department on its un-official reference No.12841/2430-III, dated the 12th August 1968.

ORDER

The Danda Daryavardi Sahkari Kharedi Vikri Sangh Limited is hereby allowed to use land measuring 186 sqyds. out of S.No. 308 of Danda for the purpose of installation of diesel pump through the Indian Oil Corporation for a period of 5 years with effect from 1-8-1968 subject to the following conditions.

1. that the Sangh should pay the rent of Rs. 1/- (Rupee One only) per annum.
2. that the pump will be installed by the Indian Oil Corporation at its own cost and will be run by the Danda Darya-vardi Kharedi Vikri Sangh Limited. The Indian Oil Corporation will be entitled to rent of Rs. 1/- only per month for the equipment supplied by it.
3. that the pump shall be used for the use of members of the Sangh only and not for the members of the public and also not for commercial purposes.
4. that the profit if any derived by sale of diesel oil to the members of the Sangh should be utilised for the uplift of the Sangh only and not for any other purpose.
5. that the supplies of High speed Diesel Oil will be made by the Indian Oil Corporation against the cash payment by the Sangh.
6. that this permission shall be liable to be cancelled and land resumed to Government without payment of any compensation for breach of any of the conditions.
7. That the Sangh should execute an agreement in form that will be prescribed by Government whenever it is called upon to do so.
