3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LCS-43247-B, dated 23rd April, 1965.

4. The possession of land shall be given to the Society only after occupancy price is paid by the Society and sanad is executed in its favour.
