2. The Greater Bombay Secondary Teachers' Co-operative Housing Society shall pay to Government the occupancy price for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department No. LGS 1034/10352-B, dated 21st January 1965.

3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LGS 43247-B, dated 23rd April 1965.

4. The possession of land shall be given to the Society only after occupancy price and development cost is paid by the Society and sanad is executed in its favour.
