Subject : Transfer of land from Survey No. 141-A of Ambivali to the Home Department for Civil Defence purposes.

MEMORANDUM.

The undersigned presents compliments to the Additional Collector, Bombay Suburban District, and in enclosing a copy of the Assistant Director of Civil Defence (Engineering and Works) Maharashtra State's secret letter, No. CD/II/WFK/2263, dated 6th October 1964, and the plan received therewith, is directed to request him to transfer to the Home Department of the Government of Maharashtra, the land measuring 8 acres from out of Survey No. 141-A of Ambivali, shown in red on the plan, for purposes of construction of buildings for (i) Civil Defence Sub-Control, (ii) Civil Defence Depot and (iii) Civil Defence Communication Centre, subject to the following two conditions :-

- (i) that the land shall be used for the purpose for which it is transferred and not for any other purpose; and
- (ii) that the land shall be relinquished to the Revenue and Forests Department as soon as it ceases to be used for the purpose for which it is transferred ^{under} to this Government Memorandum.

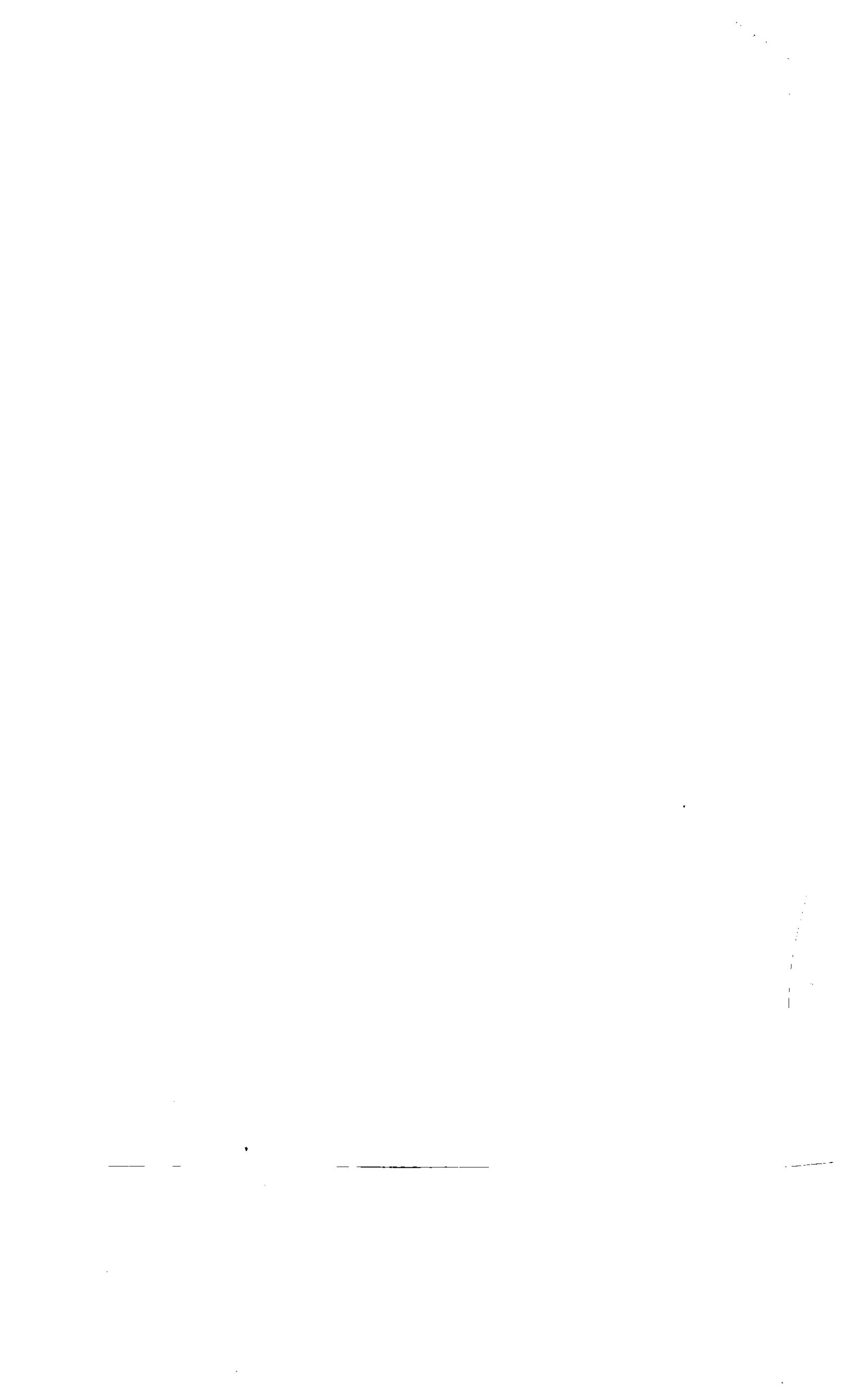

ORDER
