Resolution:- Government is pleased to grant Government Land comprising of 2 plots bearing No. 3, 4 in the layout approved by the Townplanning Department from Survey No. 111 in Ambivali in Bombay Suburban District to the Vikas Co-operative Housing Society for construction of residential buildings for accommodating its members whose list is appended to this Government Resolution duly approved.

2. The Vikas Co-operative Housing Society shall pay to Government the <sup>Price</sup> Occupancy for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department No. ICS-1064/10362-B, dated 21st January, 1966.

3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. ICS-43247-B, dated 23rd April, 1965.

4. The possession of land shall be given to the Society only after Occupancy Price and development cost is paid by the Society and same is executed in its favour.
