**RESOLUTION:** Government of Maharashtra is pleased to grant Government Land comprising of one plot of 900 yards bearing No. Three in the layout approved by the Town Planning Department from Survey No. 58 in Malund in Bombay Suburban District to the Daulkhari Co-operative Housing Society for construction of residential buildings for accommodating its members whose list is appended to this Government Resolution duly approved.

1. The Daulkhari Co-operative Housing Society shall pay to Government the Occupancy Price for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department No. LRS-1004/10352-B, dated 21st January 1966.

2. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LRS 43847-B, dated 23rd April 1965.

3. The possession of land shall be given to the Society only after Occupancy Price is paid by the Society and same is expended in its favour.
