MEMORANDUM:

The undersigned presents compliments to the Additional Collector, Bombay Suburban District, Bombay and with reference to ^{the} ~~the~~ correspondence resting with his letter NO. C/S.D.-25-1-516 dated 14th February 1960 on the above subject, is directed to convey the sanction of Land Government under Rule 22 Land Revenue Rules to the grant of land measuring 1 Acre-27 Guntas-3 Annas (i.e. 8304 square yards) out of S.H.O. 202 of Mulsad, Revenue free (holding at Rs-4,20,800/- approx) to the P.M.S.D. Industrial Home for the Blind for construction of building to provide accommodation and workshop-cum-Training Centre to the Blind men, subject to the conditions laid down in Rule 22(i) of Land Revenue Rules and to the following further conditions:-

- i) That the construction of the building should be made within a period of two years from the date of taking over the possession of land
 - ii) that the plans of the building should be got approved from the Collector and no addition or alteration should be made to it without prior approval of the collector;
 - iii) that the building to be constructed shall comply with the provision of Ribbon Development Rules;
 - iv) that the land should be used for the purpose for which grant is made and for no other purpose and that no profit should be derived out of it;
 - v) that the Institution should be open to all irrespective of cast creed, or religion;
 - vi) that the grant is liable to be cancelled and land resumed without payment of any compensation for breach of any of the conditions.
2. The Collector should execute a sanad (evidencing the above grant in form 'D' as required under Rule 32 of Land Revenue Rules.

3 Government is also pleased to direct that the Additional Collector, Bombay Suburban District, should take necessary steps for stoppage of the unauthorized use of burning ground before handing over the possession of the site of the Institution.
