3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LRS -43247-3, dated 23rd April 1955.

4. The possession of land shall be given to the Society only after occupancy price and development cost is paid by the Society and sanad is executed in its favour.
