

2. The Konkan Prantiya Co-operative Housing Society shall pay to Government the Occupancy Price for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department No. LCS-1964/10352-B, dated 21st January 1966.

3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LCS 43247-B, dated 23rd April 1965.

4. The possession of land shall be given to the Society only after Occupancy Price is paid by the Society, and is executed in its favour, the Society joins the Association of Co-operative Housing Societies in S.No. 14 Chembur the Society under takes accommodate members as will be suggested by Government, whenever any vacancy arises.
