2. The Satara Rahiwasi Sahakari Credit Society Ltd, (Co-operative Housing Society) shall pay to Government the Occupancy Price for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department No. LCS-1064/10352-B, dated 21st January 1966.
3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LCS-43247-B, dated 23rd April 1965.
4. The possession of land shall be given to the Society only after Occupancy Price is paid by the Society, sanad is executed in its favour, and the layout plan is approved by Bombay Municipal Corporation.
