MEMORANDUM:

The undersigned presents compliments to the Additional Collector Bombay Suburban District and with reference to the correspondence meeting with his letter No.C/Desk-VI/LSP/1/2/37-A dated 19.6.50, is directed to state that in the circumstances mentioned therein, Government-pleased to withdraw the orders issued in Government Memorandum, Revenue and Forests Department No.ICS 2679/1166-CR-133-54 dated 18.4.1950, cancelling the grant of plot No.33 out of S.No. 14 Chembur, Bombay Suburban District said in favour of Uplimata Co-operative Housing Society Ltd. (i.e. the plot mentioned above should be continued with the said Co-operative Housing Society Ltd) Government is further pleased to direct that the said society should be granted an extension of 7 years from the date of issue of these orders for completion of the residential building on the said plot subject to the following conditions:-

- 1) The Society should complete construction of residential building within the extended period and if it fails to do so, it will be considered as breach of condition of grant and the plot would be liable for reversion to Government without payment of any compensation as per the conditions of the original grant.
 - 2) The Society should be charged premium as laid down in Government Resolution, Revenue and Forests Department No. LND 4067/167146-AI dated 21.11.57 and the terms and conditions of the original grant should remain as they are and
 - 3) The Society should forward to Government immediately affidavits of each of its 23 new members in the form enclosed herewith, together with the income certificates and rent receipts as laid down in Government Resolution, Revenue and Forests Department No.ICS 2679/1838-CR-376-54, dated 15.7.1950 or approval of the new members. The Additional Collector, Bombay Suburban District should forward to Government affidavits and other information as indicated in (iv) in para one above.
 4. The case papers are returned herewith.
