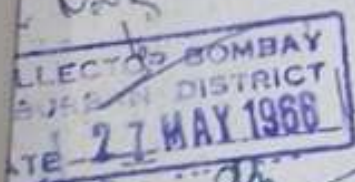

The Nav-Sahajivan Co-operative Housing Society shall pay to Government the Occupancy Price for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department, LGS-1064/10352-B, dated 21st January 1966.

The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department, LGS-43247-B, dated 23rd April 1965.

The possession of land shall be given to the Society only after Occupancy Price and development cost is paid by the Society and sanad executed in its favour.


