RESOLUTION:- Government is pleased to grant Government Land comprising of two plots of 1000 square yards each bearing No. 52, 53 in the layout approved by the Town Planning Department from Survey No. 14, in Chembur in Bombay Suburban District to the Sarvodaya Vidya Niketan Co-operative Housing Society for construction of residential buildings for accommodating its members whose list is appended to this Government Resolution duly approved.

2. The society shall pay to Government the Occupancy Price for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department No. LCS-1064/10352-3, dated 21st January 1966.
3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LCS-43247-3, dated 23rd April 1965.
4. The possession of land shall be given to the Society only after Occupancy Price and development cost is paid by the Society and sanad is executed in its favour.
