2. The Bombay Suburban Co-operative Housing Society shall pay to Government the occupancy prices for the land in accordance with the orders issued in the Government Resolution, Revenue and Forests Department No. LCS-1064/10352-B, dated 21st January, 1966.

3. The grant shall be also subject to the terms and conditions prescribed in the Government Resolution, Revenue and Forests Department No. LCS-43247-B, dated 23rd April, 1965.

4. The possession of land shall be given to the Society only after occupancy prices and development cost is paid by the Society and sanad is executed in its favour.
