Under Government Resolution, Revenue and Forests Department
No. LCS-2672/135716-BI dated 26-10-72, Sanjeev Apartments Co-operative
Housing Society has been granted plot No. 39 out of S.No. 111-D Ambivali
B.S.D. to accommodate its 12 approved members. The said Society
requested Government to grant plot No. 28 of S.No. 320 of Chembur, B.S.D.
in lieu of the plot granted at Ambivali. Government has considered
this request and has decided that allotment of plot No. 39 out of
S.No. 111-D-Ambivali, to Sanjeev Apartments Co-op. Housing Society
should be cancelled and plot No. 28 out of S.No. 320 of Chembur should
be sanctioned to the said Society subject to the conditions that:-

- i) The Society should be charged occupancy price for plot No. 28
out of S.No. 320 of Chembur in accordance with orders issued
in Government Resolution, Revenue and Forests Department
No. LCS-1064/10352-B dated 21-1-66;
- ii) The terms and conditions on which plot No. 39 out of S.No.
111-D-Ambivali was sanctioned should remain applicable in the
case of grant of plot No. 28 out of S.No. 320 of Chembur and
- iii) that the Sanjeev Apartments Cooperative Housing Society should
become member of the Federation formed by other Cooperative
Housing Societies who are granted plots out of S.No. 320 of
Chembur

action in the matter.
