RESOLUTION :- Under Government Resolution, Revenue and Forests
 Department No. LRS 2535/197101-II(Unit), dated 1st February 1967,
 3 plots bearing no. 9 to 11 in the Poston Sagar Scheme, Sector
 'D' Cluster in Bombay Suburban District were granted to Jai
 Maharashtra Co-operative Housing Society for accommodation for its
 37 members. Subsequently, two groups were formed in this Society
 and the society was split into two viz, (i) Jai Mata Co-operative
 Housing Society Ltd. and (ii) Sneh Parva Co-operative Housing
 Society Ltd. The 3 plots were shared by these 2 Co-operative
 Housing Societies in the following manner with the approval of
