Reference:-Bombay Municipal Corporation's letter No.CE/5273/  
DP, dated 31st October, 1972, addressed to you on the above  
subject.

2. The Bombay Municipal Corporation has now approached ~~to~~  
Government for early possession of the land, measuring 5.20 acres  
out of S.No. 236-A of Ghatkopar for Cemetery which is reported  
to be reserved in the Development Plan for the same purpose.  
Since the land is reserved in the Development plan for the  
cemetery, there seems no objection to grant it to the Bombay  
Municipal Corporation. You are therefore requested to verify  
the fact that the land is reserved in the Development plan for  
the purpose of the cemetery, that it is Government land and that  
it is available for grant. If these conditions are satisfied you  
may hand over advance possession of the land to the Bombay  
Municipal Corporation after taking an undertaking from it that it  
will abide by the terms and conditions that will be imposed by  
Government and also pay the occupancy price of the land at market  
rate as on 9th January 1961 i.e. the date of publication of the  
draft development plan as per Government Resolution, Revenue and  
Forests Department No.LMN 2669/194787-BI, dated 28th April 1971  
and interest at 6½% per annum on that amount from the date of

taking over possession of the land till the date of actual payment.

3. You should also get the land valued from the Town Planning Department and report the present market value as well as market value as on 9th January 1961.

ORDER :

Government land measuring 5.20 acres out of S.No.236-A of Chatkopar, which is reserved for Cemetery in the layout as shown bounded red in the plan is hereby granted for the same purpose to the Bombay Municipal Corporation on payment of the occupancy price of the land at market rate as on 9th January, 1964 i.e. the date of publication of the draft development plan and on payment of interest at 6½ % per annum on that amount of occupancy price from the date of taking over possession of the land till the date of actual payment and subject to the following terms and conditions:—

1. That the grant shall be subject to the reservation of the land in the Development plan for cemetery purposes.
2. That the grantee shall level and clear the land sufficiently to render it suitable for the particular non-agricultural purpose for which the land is granted.
3. That the grantee shall not use the land and the building erected or to be erected thereon for any purpose other than the purpose for which it is granted without obtaining the permission of

the Collector under the provisions of the code and the rules made thereunder.

4. That the grantee shall construct the structure in accordance with the plan approved and conditions prescribed by the local authority competent to approve the plan and prescribed such conditions.

5. That the grantee shall be subject to the provisions of the code and rules made thereunder.

6. That except with the previous permission of the State Government, neither the land shall be subdivided or any such sub-division be disposed of.

7. That grantee shall give an undertaking on stamp paper that it shall abide by the terms and conditions that will be imposed by Government and also make payment of occupancy price that will be fixed by Govt., in consultation with the Town Planning Department plus interest at the rate 6 $\frac{1}{2}$ % per annum, from the date of taking over possession till the date of payment.

8. That the grantee shall pay the N.A. Asstt., regularly.

9. That the grantee shall execute an agreement in the form prescribed under Maharashtra Land Revenue (Disposal of Govt. Lands) Rules 1971.

10. That for breach of any of the conditions mentioned above and such other conditions which the Collector may impose having regard to the provisions of Maharashtra Land Revenue Code and Rules made thereunder and having regard to the circumstances of the case the grant shall be revoked and the land resumed to Government without payment of any compensation.

MEMORANDUM

The undersigned presents compliments to the Additional Collector of Bombay Suburban District and with reference to Government Letters of even number, dated 29th January 1973 and August 1973 is directed to convey the sanction of Government for grant of Government land as shown below out of S.No. 206-A of Ghatkepar, Bombay Suburban District to the Bombay Municipal Corporation for construction of Cemetery and garden, as per the development plan.

2. The grant of land is subject to the following terms and conditions:-

(i) the grantee shall pay the occupancy price of the land of Rs. 531,367.75 at the market rate as on 9-1-64 i.e. the date of publication of the draft development plan, at rates shown above,

(ii) the grantee shall also pay the interest at the rate of 6½% and above the amount of occupancy price from the date of taking over possession of the land till the date of payment,

(iii) the grantee shall hold the land on inalienable and impartible tenure as occupant class II,

(iv) the grantee shall pay the non-agricultural assessment regularly,

(v) the grant shall be subject to the conditions laid down in Rules 31 and 41 of the Maharashtra Land Revenue (Disposal of Government Lands) Rules 1971,

(vi) that for breach of any of the conditions mentioned above and such other conditions which the Collector may impose having regard to the provisions of Maharashtra Land Revenue Code and the Rules made thereunder and having regard to the circumstances of the case, the grant shall be revoked and the land resumed to Government without payment of any compensation.

3. This memorandum issues with the concurrence of Finance department vide its un-official reference No. FO/12597, dated 5-10-74 and the Urban Development, Public Health and Housing department.
